Comments from the Chair

Onward & Upward

In my eight years as your East District Commissioner, I have been continually amazed at how advanced and forward thinking the Idaho Real Estate Commission has been over the years, in comparison with other jurisdictions.

Your Commission members attend three meetings a year of the Association of License Law Officials (ARELLO), where we gather information and exchange ideas with other states and countries. There are numerous programs we have implemented because of this association with other regulators. As one example, our current on-line licensing system was modeled on the Alberta, Canada model.

Currently the Commission has undertaken the most extensive change in the history of this agency! Last fall many of you received a survey from the Commission. This was the beginning of a total reshaping of all pre-license course offerings, both sales and broker pre-license.

Rapidly gathering strong support from all Commission members, is the concept of a "Post License" course, to be taken in the first license period, where new licensees would be able to practice the theories they learned in the pre-license courses.

An Education "Task Force" composed of the Education Council, Idaho Association of Realtors® representatives and Commission staff have been reviewing current curriculum and making suggestions to the Commission for changes and/or additions to the curriculum. Commission staff has been working

closely with Boise State University (BSU) in curriculum development as well.

This is a tremendous undertaking and our goal is to have the curriculum development completed for our annual Legislative Package presented to the 2007 Idaho Legislature.



2006 Legislative Changes

This year the Commission presented and had passed a single legislative bill, with no major law changes. Senate Bill 1360 will go into effect on July 1, 2006.

The bill contains small but important revisions to the Continuing Education provisions of the License Law. First, it adds to statute a previously-lacking definition for the Commission's "BCOO" course. Also, the procedure for registering to take the license exam is being taken out of statute, and will be left to the written policies and contract negotiations of the Commission. Significantly, the bill addresses licensee concerns with having to give out their Social Security numbers when signing up for CE classes – a requirement under the existing statute. Effective July 1, licensees will be able to use their license numbers to register for classes instead.

Finally, the bill modifies some classroom and test-taking policies of the Commission. Perhaps the most significant of these changes is that a student who takes and fails to pass a challenge exam no longer will be permitted to simply retake the challenge exam – as is allowed under current law. A student who fails a challenge exam will be required to take

the entire course and then pass the final exam to receive CE credit for the course. The idea behind this change is that the student who has not taken the course and does not have the information (e.g., fails the test) gains nothing by being allowed to take the test again.

This bill was developed in collaboration with the Real Estate Education Council, and approved by the Idaho Association of Realtors® Board of Directors prior to submission to the Legislature.

The Commission and the IAR® had worked together to draft a proposed Minimum Services Legislation last July. However, when the two groups could not agree on whether to include a consumer waiver or opt out provision, they agreed not to pursue a Minimum Services bill for 2006, and to revisit the issue over the summer.

Frequently Asked Questions

Q: I'm ready to renew my license, but some of my Continuing Education does not show on my record. Can I still renew?

A: You can renew your license before your education is updated. If you have completed your Continuing Education and have proof (4 hour Commission Core and 16 hours of electives) then you may renew your license.

Q: How do I check my Education?

A: To check your Education, log onto our website at <https://www.accessidaho.org/secure/irec/licensing/services.html>

Q: Where can I find a list of approved courses?

A: For a list of approved courses please see our website at <http://www.irec.idaho.gov/course-numbers.html>

Q: I know that your recording says you won't give fingerprint results over the phone, but can you tell me the status of my fingerprints anyway?

A: Because of privacy issues we are unable to give the status or results of fingerprinting over the phone. You can come into our office with a photo ID and we can

check for you. It is currently taking 7-8 weeks for the results from the day we send the card to Idaho State Police. We will send the results to the address that was on the card, within one business day of our receiving the results from Idaho State Police.

Q: I sent my application overnight to the Commission yesterday; can you give me my license number?

A: It can take up to 10 business day from the date we receive it for an application to be processed and a license number to be issued. As soon as your application is processed, we will send it to your Broker.

Q: Since Idaho has a reciprocal agreement with my State, can I sell real estate in Idaho with my Montana (or Oregon or Wyoming) license?

A: No, you will still need to go through our licensing procedures. You will need to submit a fingerprint card with the \$34 processing fee and once we notify you the results have returned okay, you can submit your application with a certified license history from your state's real estate division, a copy of your current primary license, a copy of your high school diploma or transcripts, and proof of errors and omissions insurance.

Continuing Education Audits: Are you in compliance?

The Commission is conducting monthly continuing education (CE) audits. Every month an audit report is run listing all licensees who have renewed for that month and their continuing education.

A “first letter” is sent to any licensee who does not have the required continuing education for renewal. This includes the Commission CORE course and 16 continuing education elective hours. The first letter requests proof of meeting the continuing education requirements for active license renewal, and the licensee is given two weeks to respond. Satisfactory proof of CE may include a transcript of the course taken, a letter from the provider verifying successful completion of the course, or a course completion certificate.

A “second letter” is sent by certified mail to any licensee who did not respond to the first audit letter by the required date. Failure to respond to this letter will result in immediate inactivation of the licensee’s license. Licensees who are found to have renewed out of compliance are subject to disciplinary action including a civil penalty fine.

of these numbers indicates that the number of licensees being audited, as well as the percentage of files going to the Enforcement department for non-compliance is reducing. The Commission contributes this to two things. First, the Commission changed the renewal form, beginning with November 2005 renewals, to include a list of continuing education courses credited to the licensee’s education account. As a result of this additional information, many licensees immediately update their education information. Additionally, licensees who are being audited are sharing with others, the importance of completing education requirements and renewing in compliance.

Licensees are not required to submit proof of continuing education compliance in order to renew. However, **licensees whose education records indicate continuing education compliance will avoid being audited.** The Commission will not audit any renewing licensee whose education records indicate the required Commission CORE and 16 hours of elective education.

To access your education account, go to www.irec.idaho.gov. Click on “Licensing Forms and Online Services.” Click on “Online Licensing Services.” Type in your Username and Password, and once in, click on “Education Report.” Not registered as a User? It’s easy! Just follow the “New Users” instructions on page 14.

Referral Fees

from the Idaho Department of Finance, Consumer Finance Bureau

Despite changes to the Department of Housing and Urban Development's position on compensation to real estate sales brokers for administrative costs, referral fees remain illegal under the Real Estate Settlement Procedures Act (RESPA).

The Department of Housing and Urban Development announced a \$150,000 settlement with a New England mortgage company in its November 17, 2005 news release. The settlement states that the company solicited and received various types of entertainment tickets from certain settlement service providers in exchange for the referral of business.

RESPA was enacted to provide borrowers advance disclosures of settlement costs and to prohibit illegal kickbacks and excessive fees associated with the home buying process. Section 8 of RESPA prohibits a person from giving or accepting anything of value in exchange for settlement service business referral. Licensees should review the requirements and prohibitions of RESPA with their employees to ensure compliance. Information received by the Department of Finance pertaining to possible violations of Section 8 of RESPA will be reviewed both as potential violations of the Residential Mortgage Practices Act and may be forwarded to HUD and its RESPA Enforcement Office for further investigation.




The Care and Feeding of Your Real Estate License: Continuing Education

Recently the Idaho Real Estate Education Council, with the support of the Idaho Real Estate Commission, sponsored the annual Instructor Development Workshop. This conference, or workshop, is done for the benefit of all attending instructors as well as those who might be interested in becoming instructors. This year the workshop provided a focus on instructor use of PowerPoint instructional techniques. This is also the time that the Council writes the initial CORE class for the coming year. The workshop is a requirement for becoming a real estate instructor and remaining certified. It also provides an opportunity for completing several continuing education credits.

A great deal of effort goes into providing continuing education classes for all licensees. The Commission and the Education Council provide the channel for the approval of all instructors and the classes offered. The Commission also asks the Education Council to write and provide appropriate courses as needed for the benefit of the real estate industry in Idaho. All courses submitted to the Education Council are reviewed and discussed. The topic and content of the courses submitted must fit within the guidelines provided by the License Law and Rules for Idaho. For example, some of the topics approved for continuing

education courses include: ethics, legislative issues that influence real estate practice, real estate law, agency, fair housing, affirmative marketing, ADA, finance, land use, investment, etc. just to point out a few topics. If there is a question or concern on submitted class topics, the Commission and the Council have the final approval authority.

The online licensing system has been designed to allow greater protection for your personal information. You will use an **Access Idaho** username and password to access your IREC licensing information. FEE CHANGES

Effective July 1, 2006, new license and license renewal fees (\$180) are being **reduced**. The new fee will be \$160 which includes \$20 for the recovery account.



Do I Have to Give Out My Social Security Number?

It depends. Do you know your license number? Many licensees are reluctant to give out their social security number and understandably so.

The State of Idaho requires social security numbers for identification purposes. The Commission requires a social security number for each applicant applying for a license. After this initial application, however, the licensee's identification and data is tracked by the social security number OR the license number.

The license number is not confidential information. An Idaho licensee, attending continuing education classes, must be permitted to use his/her license number instead of a social security number. (Prelicense students, on

the other hand, will not yet have an Idaho license, and therefore social security numbers have to be used to verify attendance.)

Providers offering continuing education courses have an obligation and a responsibility to ensure that student confidential information is not disseminated or used for purposes other than the creation and submission of a course completion list to verify attendance to the Commission.

So the next time you register for a course, you have the option of using your license number or social security number. The choice is yours. Learn your license number!

Power Outage at the Idaho Real Estate Commission

This past April circumstances beyond our control brought the IREC online licensing system to a crashing halt. First a power outage affected a major area of downtown Boise from 7:30 a.m. to 10:15 a.m. keeping the Commission in the dark and the online system inaccessible. Then when power was restored, Qwest discovered that the power problem had caused a problem with their DSL lines. This situation was not resolved until 4:00 in the afternoon, and also kept IREC's online system inaccessible until that problem was resolved. Unfortunately, the timing of these problems was really bad, because it occurred during the last week of the month when many licensees are attempting to get their last minute renewals processed. This outage serves as a reminder that licenses really shouldn't wait until the last minute to renew your

real estate license online, because it just might be that moment the power goes out! Give yourself a little "breathing room" and renew your license before it expires and you are hit with fines for working, advertising, hosting open houses, showing, etc. while your license is expired. Both you and your broker are liable for substantial fines if that happens for even a few hours. Real estate licenses expire at 5:00 p.m. on the expiration date printed on your license and also printed on your renewal notice. You have two years to complete Continuing Education courses and you can renew your license any time in the 90 days before it expires, but the renewal must be RECEIVED in our office by 5:00 p.m. on the last day of the month of your birth. Sorry, no exceptions for power outages.

Lead Generators—Should They Be Licensed? from the Idaho Department of Finance, Consumer Finance Bureau

The onset of loan originator licensing has brought an increased number of requests for opinions as to whether lead generators are required to be licensed—either as individual loan originators, or as a mortgage broker, in the case of the employing or contracting firm.

One scenario pertains primarily to web-based lead generation. The firm desires to set up a “matching service” portal in which borrowers can enter certain data information on a secure website that is fed to prospective brokers or lenders (“receivers”) for loan consideration. The receivers then follow up directly with the consumer to present program options and obtain further information. The firm receives compensation based on the leads provided to the receivers, regardless whether an actual loan is completed, and has no further involvement in the process once the lead is delivered.

The requirement for licensing in this case may hinge on the information the portal data form requires the consumer to complete. An argument that the collection of borrower data is not an application because an application form, such as a FNMA 1003, is not completed is not necessarily correct. Collection of certain data, or a specific combination of data, may constitute solicitation of an application, or an offer to assist in the completion of an application, regardless of the format.

If the collection of information is limited to items such as the consumer’s name, current address, phone numbers, best time to contact, email address, state where property is located, preferred type of interest rate (fixed or variable), property type (occupancy), self-assessed credit history (i.e. poor, fair, good, excellent), loan amount desired, and type of loan desired (purchase/refinance), then it would appear licensing would not be required. However, if requested information adds items such as income, occupational status, existing loan balances, loan payment amounts, monthly debt payment, assets or a combination, then

this would represent an application or a solicitation of an application, and not solely a lead contact.

Another scenario involves a mortgage licensee desiring to hire a marketing person as a W-2 employee to generate referrals. The marketing person visits real estate agents, builders, trade shows and may contact consumers directly with information available through their employer. Information provided may range from a rate sheet flier with licensee contact information, to verbal discussion on programs available and qualifications, to application packages.

If the marketer limits the contact to handing out business cards, rate sheets, networking by discussion of the personalized service to be offered or collecting basic contact information of interested parties (i.e. name, phone, address, best time to contact), and refers any additional contact back to the licensee, then licensing the marketer as a loan originator would not be required. However, if the marketer enters into discussion of programs, qualifying requirements, terms and conditions of loans, answering inquiries as to income and debt or credit requirements, solicits applications through discussion, action or print materials, or becomes involved in an application process, then licensing would be required.

It is the activities conducted, or to be conducted, by a person or company that dictates whether licensure will be required, not a job title. Definitions for mortgage brokering, mortgage lending and mortgage loan origination activities may be found in the Idaho Residential Mortgage Practices Act in IC §26-3102 (18)(19)(20). If a formal opinion is desired for a specific scenario, please submit the request in writing with all pertinent details—what will be done vs. what specifically will not be done—to the Consumer Finance Bureau.
