Comments from the Chair

Banff, Alberta, Canada. During this conference we met with regulators from jurisdictions from across the nation and around the world to learn and share in hopes of improving how we conduct business. I am including a presentation in this article that we heard at the conference called, "The Top Ten Causes of Unprofessional Conduct" by James T. Casey, Q.C. It is my hope you will find this presentation interesting and helpful.



THE TOP TEN CAUSES OF UNPROFESSIONAL CONDUCT By James T. Casey, Q.C.

Based on my experience over the years with hundreds of unprofessional conduct cases in a broad range of professions, the following is my unscientific list of the top ten causes of unprofessional conduct. In no particular order:

1. Failure to maintain currency of professional knowledge and competence
 - Professions evolve. Professionals must keep pace with the change.
 - There are many complaints of unskilled practice about professionals who once were very competent but who have not maintained their competence.
 - "That's how we did it when I was trained 20 years ago" is not a valid defense.
2. Failure to seek assistance or make appropriate referrals
 - Professionals may encounter difficult situations for which they do not have the necessary skills. Unprofessional conduct may occur where the professional

"plows ahead" without getting assistance.

3. Difficulties in a professional's personal life affect their work life

- We rarely have "water-tight compartments" in our lives. Our work can affect our personal and home life, and difficulties in our personal and home life can negatively affect our work.
- Personal difficulties might be related to problems with marriage, relationships, children, finances, or depression.
- It is common for serious personal difficulties being experienced by a professional to "spill over" into the workplace, giving rise to a risk of unprofessional conduct.

4. Alcohol and drug addictions

- Alcohol and drug addictions are the root cause of some of the most serious cases of unprofessional conduct.

5. Poor communication

- Many unprofessional conduct complaints are caused by poor communications between the professional and the customer or client or between a professional and their colleagues.

**EXECUTIVE DIRECTOR'S
REPORT**

There is an old saying that “the only thing constant in life is change”. That saying definitely applies here at the Real Estate Commission.

In the last 4 months, we have observed the retirement of longtime employee, Joanna Marshall, who most recently served as our Information Technology Specialist, after having done a number of jobs at the Commission over the years. Joanna began her stint at IREC 30 years ago, well before there was an “IT” department, and we will miss her institutional memory and her gift for proofreading! Karen Seay, who has been our Education Director for the past two years, has accepted a new opportunity with the State Department of Education. Karen left some very big shoes to fill – we can’t believe how lucky we are to have had the benefit of her professionalism and expertise in her work with Commission Staff and the Education Council. Last but certainly not least, Terry Ruetters, our own living legend and Chief Investigator, celebrated his retirement on June 29th after more than 15 years with the Commission. Underneath that gruff exterior resides a big heart and a passion to do the right thing for the benefit of our licensees and the public. We are sorry to lose Terry’s in-depth knowledge of the license law and his comprehensive understanding of the real estate industry.

While we are sad to say good-bye to some old friends, there is a silver lining! IREC welcomes Will Robinson, who joined us in March as our IT specialist. Will brings a wealth of website knowledge and networking experience to the Commission. He has already begun revamping the IREC website to make it more user friendly. This will be an ongoing process over the next several months, and if you have suggestions for changes, please do not hesitate to contact him. We encourage you to visit www.irec.idaho.gov to follow the progress. We are pleased to announce that Craig Boyack has been promoted to the Chief Investigator position. Craig began his IREC career over five years ago, starting out as our auditor and working for the last several years as an investigator in the Commission’s Enforcement Department. In addition, Craig has experience as a real estate licensee and a land surveyor, and we are thrilled that he has agreed to move into this supervisory position. At this writing, we do not yet know who will be our next Education Director. We do, however, continue to benefit from the assistance and knowledge of our dedicated Education Department personnel, Danielle Lefler and Jesama Rosensweig, who will be happy to assist you with your education questions.

IREC’s 2007 update legislation, S 1109, contains a number of changes that affect the way our licensees will conduct business. (To read the full text of S 1109, please visit the IREC website.) First, physical license certificates are no longer required to be displayed. A licensee may still request a certificate from the Commission for a \$15 fee, or a licensee may print a certificate from the IREC website at no charge. Second, an agent is no longer required to obtain the seller or seller’s agent signature to verify the time and date of receipt of an

offer to purchase. Trust account ledger records may now be kept either in alphabetical or transaction number (chronological) order. The Commission now has the authority to adopt minimum teaching standards for its certified course providers and those standards will be set forth in administrative rule.

A licensee may now obtain 4 hours of continuing education credit for attendance at a regularly-scheduled commission meeting (increased from 3 hours), and 7-day advance notice is no longer required to attend a meeting for CE. The Commission held its April meeting in Pocatello where we had an outstanding turnout of nearly 50 licensees who attended for CE credit, thanks to Commissioner Kelly Fisher and Mike Johnston, Designated Broker of The Home Specialists in Pocatello. We very much appreciate the warm welcome and the opportunity for our licensees to see what goes on at a Commission meeting. The September Commission meeting will be held in Coeur d’Alene in conjunction with the Idaho Association of REALTORS® convention. We look forward to seeing you there!

Many licensees do not know that the civil penalty fine money collected by IREC for violations of license law is held in a special account and can be used only for the development and delivery of real estate education for our licensees. The Commission is looking at more ways to use this money for your benefit, in addition to the current grant process for development of new courses. Your suggestions again are always welcome. Stay tuned for more information on this topic.

6. Failure to appropriately address client concerns

- A customer or client with a concern about their file or a professional's conduct will typically first approach the professional or the broker about their concerns. Many unprofessional conduct complaints are filed because the person felt that their concerns were not taken seriously by the professional.

7. Environmental factors

- Various environmental factors can be a contributing cause to a professional engaging in unprofessional conduct. For example, there may be excessive work demands, a lack of mentoring and supervision, or inappropriate workplace practices. A professional may also be assigned tasks by their broker which the professional is not completely competent to perform due to inexperience or lack of training in a particular area.

8. Personality conflicts escalate to unprofessional conduct

- It is not unusual for the roots of unprofessional conduct to be in a personality conflict between a professional and a colleague, between a professional and his broker, or between a professional

and a customer or client. A serious personality conflict can cause a professional to lose their objectivity, and a minor dispute which should have been resolvable may escalate to a major confrontation.

9. Complacency about professional standards

- Some professionals with a great deal of experience become complacent about professional standards and begin to develop "sloppy" practices.

10. Professional documentation

- A failure to adequately document causes significant problems for professionals.
- If you have acted professionally and appropriately, then proper documentation will be your best defense.
- Many unprofessional conduct complaints are referred to a hearing because of significant disagreements about what actually happened. If a case comes down to "He said, she said," then you are at risk. Appropriate documentation can objectively demonstrate what really happened.

Professionalism is not about perfectionism. All professionals make mistakes. However, we all need to ensure that we learn from our mistakes. By being alert to some of the root causes of unprofessional

conduct, we can do our very best in ensuring that we act as "true professionals".



Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain his CE in a timely manner. Given a formal reprimand; ordered to pay a \$500 civil fine; and required to pay the costs and attorney's fees.

**Anderson, Skinner E. II**, sales associate with Compass Commercial Properties LLC in Boise, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) for failure to obtain CE in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and required to pay costs and attorney's fees.

**Barajas, Silvia E.**, formerly with El Centro Real Estate Inc., in Nampa, Idaho. Voluntary surrender and permanent termination of her Idaho Real Estate license.

Given a formal reprimand; ordered to pay a \$1,000 civil fine; and the costs and attorney's fees.

**Bryan, Julie F.**, designated broker with Windermere Real Estate/Teton Valley in Jackson, Wyoming. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain Continuing Education (CE) in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and the costs and attorney's fees.

**Carr, Erica S.**, sales associate with Ernie Carr Real Estate in Garden City, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and the costs and attorney's fees.

**d'arcRaven, Jennifa**, inactive sales associate formerly associated with Tamarack Resort Realty LLC in Donnelly, Idaho. Stipulated to

violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) for failure to obtain CE in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and the costs and attorney's fees.

**Grau, Maya Pavane**, designated broker of Pavane Real Estate Brokers Chtd. LLC, in Meridian, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner, and 54-2060(7) - misstatement in her renewal of license. Given a formal reprimand; ordered to pay a civil fine of \$1,000; and the costs and attorney fees.

**Grundty, Bruce F.**, salesperson with Coldwell Banker Johnson & Company in McCall, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain Continuing Education (CE) in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$250; and the costs and

attorney's fees.

Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain Continuing- Education (CE) in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and the costs and attorney's fees.

**Hellwege, Richard H.**, sales associate with Re/Max Advantage in Nampa, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) for failure to obtain CE in a timely manner. Given a formal reprimand; ordered to pay a civil fine of \$500; and the costs and attorney's fees.

**Helzer, Thomas L.**, sales associate with Evans Realty LLC in Emmett, Idaho. Stipulated to violation of Idaho Code sections: 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner. Given a formal reprimand; he was ordered to pay a civil fine of \$250; and the costs and attorney's fees.

**Higginbotham, Jan S.**, designated broker with Boise Places LLC, in Boise, Idaho. Stipulated to violation of Idaho Code sections 54-2038(1)(b) - failure to supervise; and 54-2054(7) - accepting fee from both sides without written disclosure. Given formal reprimand; ordered to pay a \$500.00 civil penalty fine; ordered to pay the actual costs an attorney's fees of \$1,311.51; and required to successfully complete a live Risk Management course.

Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner. **Hutchison, Robert M.**, sales associate with Alpine Realty, in Twin Falls, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner, and 54-2060(7) - misstatement in his renewal application. Given formal reprimand; ordered to pay \$500 civil fine; and the costs and attorney fees.

**Jesseph, Rose C.**, formerly with Exit Realty Coeur d' Alene in Coeur d' Alene, Idaho. Voluntary surrender and permanent termination of her Idaho Real Estate license.

**Locati, Matthew James**, inactive sales associate formerly with Team Realty in Nampa, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner. Given a formal reprimand; ordered to pay a \$500 civil

## EDUCATION UPDATE

### IREC continuing education audit process

The continuing education audit process has changed! It is now streamlined and more efficient.

Each month the education department reviews the list of license renewals for a particular month and identifies those licensees who do not have sufficient continuing education credited to their education account.

Instead of a First letter and a Second letter, there is now just ONE letter. This Notice of Continuing Education Audit letter is mailed to the licensee at both the licensee's home and work addresses as on file with the Commission. A separate notice letter is sent to the licensee's designated broker. This is the **only** notice given.

*Did you know? Licensees are required by law (IC 54-2018(9) to provide written notification to the Commission of any change in personal information within ten days of the change.*

Licensees have 2 weeks from the date of the letter to respond. If the licensee responds timely to the audit letter and provides proof of sufficient continuing education, the licensee is notified in writing of fulfillment of the audit requirements and the audit file is closed.


If the licensee responds to the audit letter but cannot provide proof of sufficient continuing education, then the education department will work with the licensee to get the licensee into compliance in a *timely manner*. After the licensee has come into compliance, the file will be turned over to the enforcement department for possible disciplinary action pursuant to IC section 54-2018(5). If the licensee fails or refuses to timely come into compliance with the continuing education requirements, then the licensee is treated in the same manner as a licensee who fails to respond.

Failure to respond to a continuing education audit will result in the inactivation of the license pursuant to Idaho Code section 54-2018(8) and the licensee's file is turned over to the enforcement department for disciplinary action.

With that said, approximately 98% of renewing licensees each month are in compliance!

### Duties and requirement of all certified providers

Certified providers now have the legal duty to take reasonable steps to ensure that the instructor (certified or non-certified) is competent to teach the course. Additionally, the provider is required to maintain resumes or other biographical information that documents the qualifications of the instructor. The provider is responsible for making such documentation available to the public and Commission upon written request. A course provider may not offer for credit any course that is being taught below the minimum teaching standards established by the Commission or that is being taught in a manner that is detrimental to the purpose of educating licensees. *For a copy of the Minimum Teaching Standards, contact the education department at 208.334.3285 ext. 102 or visit [www.irec.idaho.gov](http://www.irec.idaho.gov).*

Given a formal reprimand; ordered to pay a civil fine of \$750; and the costs and attorney's fees.

**Miley, Cynthia Harper**, sales associate with Windermere Real Estate/Sun Valley LLC, in Hailey, Idaho. Stipulated to violation of Idaho Code sections 54-2023(1)(a) - failure to obtain CE in a timely manner, and 54-2060(10) and 54-2060(7) - misstatement in an application for renewal of a real estate license. Given a formal reprimand; ordered to pay a \$1,000.00 civil fine; and required to pay costs and attorney's fees.

**Moses, C. Lynn.**, designated broker with Continental Real Estate Company in Driggs, Idaho. Stipulated to violation of Idaho Code sections 54-2085(4) - failure to use the correct Representation Confirmation and Acknowledgment of Disclosure in the Purchase and Sale Agreement; and 54-2045(1) - failure to deposit earnest money at an approved depository in a timely manner. Stipulated to violation of Idaho Code sections 54-2023(1)(a) and 54-2060(10) - failure to obtain CE in a timely manner, and 54-2060(7) - misstatement in her renewal application. Given a formal reprimand; ordered to pay \$250 civil fine; and the costs and attorney fees.

**Pond, Tyler G.**, sales associate with Allpro Realty Group Inc. in Boise, Idaho. Stipulated to violation of Idaho Code sections: 54-2054(7) - failure to make a full disclosure in writing that the salesman/brokerage was being compensated by both parties to the transaction; 54-2045(4) - failure to deliver to the broker all consideration, including checks held in uncashed form, received by the sales associate

in connection with a real estate transaction; 54-2055(2) - failure to disclose in writing that the licensee/buyer holds an active real estate license; and 54-2051(4)(b) - misrepresenting the actual form and amount of the consideration received as earnest money. ## Frequently Asked Questions

**Q: My clients canceled their listing agreement. I do not agree with this decision, and intend to dispute this cancellation. (This is known as a unilateral, or one party, cancellation.) Can I just enter the property as “withdrawn” in the Multiple Listing Service until this is resolved?**

A: No! You have every right to dispute the unilateral cancellation, but this is the wrong approach. If the seller sells the property during the time period on the cancelled listing, you have a right to sue them for a sales commission. Your success or failure will be decided in civil court. The fact remains that your listing is cancelled from the date the seller notifies you forward. You have an obligation to make sure none of your advertising will provide misleading information to the public (or their licensees). The listing was cancelled, not withdrawn, and you are aware of this, even though you do not agree with it. Make an accurate representation.

**Q: Can I perform other services for my clientele, and charge a fee for these services?**

A: Yes, with some reservations. There are licensees out there who originate loans, operate escrow companies, are auctioneers, etc. They can perform these services as a stand alone business, of course. They can also perform these services on transactions where they are acting as licensees. In this case you must make a written disclosure that you intend to receive a fee for the additional service you are providing. This disclosure must be made to the buyer and the seller prior to closing. Other agencies may impose additional requirements. These could be the Idaho Department of Finance, Department of Insurance, and others.

**Q: Does Idaho statute require a one-year warranty on all new construction in Idaho?**


A: There are certain warranties that go along with a builder’s membership in different associations and there are warranties available through third parties, but there is no one-year warranty required by statute. For a warranty to be included as an enforceable part of the purchase and sale agreement, the agreement must either expressly state the terms of the warranty or specifically reference a

separate document that outlines what the terms of the warranty are. Unless a warranty is sufficiently identified in the agreement, it will not be an enforceable term of the sale.

**Q: If a customer or client does not sign or initial and date the bottom of an individual page of a purchase and sale agreement, does that void the contract in its entirety?**

A: No. It is our understanding that courts will not typically void a contract, especially a purchase and sale agreement for a home, because a party claims he or she didn’t read or see all of the contract before signing it. The signatures at the end of the contract indicate the parties’ consent to all terms of the agreement as written.

The signatures or initials and dates at the bottom of each page document that the buyer or seller did, in fact, see, read and agree to the terms specified on each page of the contract.

## “Let the numbers tell the story”

Idaho is fortunate to have one of the best real estate education programs in the nation. The primary reason for this success is the emphasis placed by the

Idaho Real Estate Commission on education. The utilization of an appointed Idaho Real Estate Education Council provides a continuing review of licensee education programs. Since 1982, Idaho has received **17 EDUCATION AWARDS** from The Association of Real Estate License Law Officials (ARELLO) and The Real Estate Educators Association (REEA).

A few years ago, the availability of elective continuing education courses was limited. Great strides have been made to offer varied alternatives for licensees to obtain required or additional education. Recently the list of Approved Topics for Continuing Education was expanded with additional topics now qualifying for course approval.

During the past year (May 2006 – May 2007) **164 NEW COURSES** were approved to be taught in Idaho.

Instructors for these continuing education courses are approved by the individual providers (schools). During this past year, **13 NEW INSTRUCTORS** were approved to teach Commission developed courses. Also during the same period, **34 NEW PROVIDERS** were approved.

Traditionally, the Commission CORE course has always been a **4 HOUR** course. CORE 2007 (effective July 1, 2007) will be a **3 HOUR** course.

Currently, all the Commission developed courses are being reviewed. Also, a post license education requirement is being investigated. The future brings us the opportunity to further improve Idaho’s real estate education.


CARE: Please do not mark or turn down pages in books. Do not expose tapes to extreme temperatures.

**Brokers don't get caught with your license down!**

Give me an "S"! Give me a "U"! Give me a "P"! Give me an "E"! Give me an "R"! Give me a "V"! Give me an "I"! Give me an "S"! Give me an "I"! Give me an "O"! Give me an "N"! What do you have "SUPERVISION"! **WRONG!** What we have is a lack of **BROKER SUPERVISION!**

It is my understanding that at one time all it took to get a real estate license was \$10 and a letter from three people attesting to your good character. You then went to work for a broker who normally had only one or two sales associates, and the broker taught you all about real estate, similar to an apprenticeship. You were paid a share of the brokerage fee- normally less than 50%. The broker had a real interest in his new associate, since the more financially successful the associate, the more the broker made. The broker paid for everything- the signs, the advertising, the paper clips, and the secretary. After two years the sales associate could become a broker.

Times are changing, and now we have offices that have hundreds of sales associates and many of these have never even spoken to their broker. Instead, we now see "Teams" and "Mentors" taking the place of the broker – an obvious market reaction from the sales associates who found themselves without someone to go to for answers and advice.

We have gone from traditional commission splits; to flat desk fees (\$500-\$900); to small monthly fees (\$25-\$150) plus a set amount for each deal (\$250-\$350) and the agents paying for all their expenses from advertising to paperclips. Regrettably, these business models provide no incentive for the designated broker to care about the financial success of his/her sales associate as long as her/his fees are paid. So there is

less interest in assisting the new associate to succeed or assisting in training him or her on how to put deals together.

These days, it seems that many brokers are too busy doing their own thing to actually do the things the law requires them to do. So they hire office managers to check the transaction files. While an office manager can be extremely efficient, especially when they tell the agent to get the form signed or no commission check, they typically are not licensed and don't have the broker's experience when looking at the structure of the deal.

Under the law, brokers are required to have both the education and the actual transaction experience and knowledge to become the designated broker. Under the law, designated brokers are required to **"review and approve of all real estate agreements."** Only by **actually looking at those listing or purchase and sale agreements** can they tell what their sales associates are doing. Double contracts and loan fraud can easily be seen just through this one supervision act.

By **"being reasonably available to manage and supervise the company"** – which is required by statute - the designated broker should be looking at his or her associates' advertising and websites, making sure they are doing it correctly, that what they are offering to do is actually legal, and that it is done in a manner the broker approves of.

Unfortunately, we are seeing more and more brokers becoming the designated broker for more than one company - the **current record is six different offices.** With so many offices, these designated brokers have become no more than a rent-a- broker, with very little interest in their sales associates or what they are doing. **If you are the designated broker you are responsible for everything your sales associates or office staff do, no excuses. You are where the buck stops, not where it is passed or dropped.**

Also, in any transaction in which you are the "responsible broker," you are the individual who is RESPONSIBLE for the closing, for all the deposits, and for disbursements at the closing. This means that you should be reviewing these closing statements to see that what was agreed between the buyer and seller has actually happened. Too many times lenders convince sales associates to do things that amount to double contracts or loan fraud, and the sales associates just

don't appreciate what's actually going on, or else they need the sale too much to question the lender. Designated brokers should be able to spot these things and counsel the sales associate on how to proceed correctly, and without the risk of losing his or her license, or worse, looking at jail time for being a party to loan fraud. A broker should be willing to fire a sales associate, and to file a complaint with the Idaho Real Estate Commission against any sales associate who persists in this type of behavior.

We are seeing more and more double contracting by sales associates using inflated prices to buy and sell properties. If I were a broker and a sales associate brought in a contract which was showing a \$20,000 or \$30,000 bonus plus a 6% brokerage fee, I would be wondering how it came to pass, especially if that sales associate happens to be the buyer. I sure would be looking at the listed price and wondering if there was a slight chance the agent was playing games and had just committed loan fraud.

Designated brokers need to take a second look anytime one of his /her sales associates wants to buy a property, making sure it is above board to both the consumer and the lender. The broker needs to make sure the sales associate is making the right disclosures

Sure, it's nice that real estate sales associates have Errors and Omissions Insurance. But it does not save them when they commit fraud or when they are dealing with their own properties either as a buyer or a seller. It won't save the broker either from legal expenses and costs, or the embarrassment of seeing their name on a lawsuit.

Designated brokers have a RESPONSIBILITY to both their licensed sales associates and the consumer. If you don't want it or can't handle it, then don't be one. The responsibility is really pretty simple, and it comes with the title.

Do the things you agreed to do when you got your license and you won't be caught with your license down.

# Information From The Licensing Department

## New Laws/Policies

There are only a few new laws and a policy change this year that will affect you. There are three (3) specific laws and one policy change that have a major impact on you, your designated broker, and the licensing department.

The first law change will affect physical license certificates. A physical license certificate will no longer be required. Effective July 1, 2007, the Commission will stop issuing printed license certificates. A licensee or designated broker may request a printed license from the Commission for a \$15 dollar fee, for each license requested.

The second law change affects the cost of company address or name changes, office transfers, and personal name changes. Effective July 1, 2007, there will be no charge for these changes. If a licensee or designated broker would like to request a printed license, they may request one for a \$15 dollar fee for each license requested from the Commission. Licensees and brokers may make changes on-line, and will still have the opportunity to print a free license certificate on-line.

The third law change – which applies to all Idaho agencies that issue professional or commercial licenses – requires that the Commission verify the “lawful presence in the United States” of each individual license applicant. Effective July 1, 2007, each renewing applicant will have to attest, under penalty of perjury, that he or she is a U.S. citizen, permanent resident, or otherwise lawfully present in the U.S. New license applicants will, also, be required to provide proof of their lawful presence here.

The fourth change will affect active licensees who have allowed their Errors & Omissions insurance to expire. Licensees will no longer be able to avoid a fine by stating that he or she has not engaged in practice during the uncovered period. From now on, fines will be assessed against any active licensee who fails to maintain E&O insurance during the active license period. Fines will range from \$100 - \$200 dollars, depending upon the length of time without insurance.

### Errors & Omission Insurance

HOT..... HOT..... HOT.....

A reminder to those licensees having Group E&O Insurance with Rice Insurance Services Company (RISC), your policy is due for renewal on October 1, 2007. Renewals will be mailed out to all individuals at their licensed business address on August 15, 2007. The annual premium will be increasing. The new premium renewal rate is \$165 dollars per year. You may renew your E&O insurance starting August 15, 2007 through October 1, 2007 either by mail or on the internet. To renew on the internet go to <http://www.risceo.com>. After October 2, 2007, licensees who have not purchased E&O will be subject to fines and penalties.



# Attend A Commission Meeting For 4 hours Continuing Education Credit!!

Regular public meetings of the Idaho Real Estate Commission are held monthly. Although meetings are normally held at the Commission Office in Boise, dates, places, and times are subject to change.

Business normally conducted during Commission meetings includes:

## INFORMATION TO OUT-OF-STATE REAL ESTATE BROKERS\*\*

This Guideline is designed to inform out-of-state real estate brokers that, in order to engage in any real estate brokering activities involving Idaho property, the broker must hold an active Idaho real estate license.

### **1. An Idaho license is required to engage brokering real property located in Idaho.**

Idaho law flatly prohibits anyone from engaging in acts of an Idaho “real estate broker” without an active Idaho real estate license.

A “real estate broker” is defined in Idaho Code Section 54-2002 to include any person who, directly or indirectly, while acting on behalf of another for compensation or promise or an expectation there of, does any of the following: sells, lists, buys, negotiates or offers to sell, list, buy or negotiate the purchase, sale, option or exchange or real estate or any interest there in. A “real estate broker” also includes any person who represents to the public they are engaged in any of the above activities. It also includes any person who engages in the procurement of prospects.

The Idaho Real Estate License Law also prohibits out-of-state brokers from advertising, or being named in an advertisement concerning, real property that is located in Idaho.

### **2. Referrals and payment of referral fees are permitted.**

If an out-of-state broker has a customer or client wishing to purchase real property in Idaho, the Idaho License Law allows the out-of-state brokerage to *refer* the client to a licensed Idaho brokerage, and for the Idaho brokerage to pay a *referral fee* to the out-of-state brokerage. See Section 54-2054 However, the Idaho brokerage must handle *all* aspects of the transaction from that point on.

Examples of activities for which an Idaho license is required include, but are not limited to:

- advertising the property;
- showing the property;
- preparing purchase and sale agreements forms; and
- negotiating of the purchase and sale agreements.

It is not enough for an out-of-state brokerage to simply “refer” the buyer but then continue to perform the licensed real estate brokering activities in this state. Without an Idaho license, the out-of-state brokerage cannot engage in *any* acts of a “real estate broker” with respect to

---

\*\* *In this Guideline, “out-of-state broker” is a broker that does not hold an active Idaho real estate license.*

property located in this state.

Likewise, if an out-of-state brokerage has a seller who owns Idaho real property and wishes to sell it, the out-of-state broker may *refer* the seller to an Idaho licensed brokerage and receive a referral fee. Idaho law does *not* allow for “co-listing” with an unlicensed brokerage.

### **3. Sanctions for unlicensed activity.**

Unlicensed brokering activity is a misdemeanor crime in Idaho punishable by imprisonment and a fine of \$5,000 for individuals and \$10,000 if a business entity is involved. In addition, the Idaho Real Estate Commission is authorized to take administrative action against anyone engaged in unlicensed activity, and to assess a civil penalty up to \$5,000 and \$10,000, plus costs and attorney fees.

7. 54-2065. Penalty for Acting as a Broker or Salesperson Without License.
