**COST** - \$185 for both CORE and IDW; \$85 for CORE only; \$125 for IDW only; and \$0 for Provider Training.

**SEATING IS LIMITED** —Your place will be confirmed upon receipt of the registration fee.

**CREDIT** - Real estate license continuing education credit is available for attending the 2020 Core on March 10, 2020. Course credit will be posted with an effective date of July 1, 2020 (the date of course certification). No CE credit will be given for the March 11, 2020 IDW.

**Instructors are required to attend IDW or its equivalent at least once during the two years preceding the instructor certification period. You must attend the entire IDW to obtain credit for instructor certification.**

**To be certified to teach the 2020 Core, you must attend 100% of the course and pass the final exam with a minimum score of 70%.**

**\*Providers are required to attend Provider Training at least once every two years to renew certification. This requirement can be satisfied by attending the Provider Training session at IDW or by attending a Commission-approved Provider Training session via web conference.**

**REFUND POLICY** - If written notification of registration cancellation is received by the Commission at least five (5) business days before the course commencement date, the registration fee, less cost of materials received, will be refunded. No refund will be made due to non-attendance. In the unlikely event any course is cancelled due to insufficient registration, a full refund will be made to all registrants.
